- 1. Approve the Minutes of the Meeting Held on April 14, 2010 Hanson asked for additions and/or corrections. There being none, Dewar made a motion to approve the minutes as submitted. Vogel seconded the motion. All ayes, motion carried.
- 2. Financial Reports Dewar made a motion to approve the Finance Committee's recommendation to approve the Borough's Financial Reports, including the amendments to the List of Bills Report, and to pay the outstanding bills except for the bills to GAI Consultants, which totals \$54,595.97; the bill from ASAP Court Reporting, which totals \$300.00; and the bill from Tri-Star, which totals \$422.00, payment should be withheld. Dewar made a motion, based on the recommendation of the Finance Committee, to approve the Summary of Account Balance Report as presented. Stern seconded the motion. All ayes, motion carried.

Dewar made a motion to authorize the Borough Manager to transfer \$134,745.82 from the PNC Bank Line of Credit to pay the invoices from CME Engineering, in the amount of \$16,281.35; New Enterprise Stone & Lime Company, in the amount of \$379.47; and Howard Concrete Pumping Co., Inc., in the amount of \$118,085.00. Cornez seconded the motion. All ayes, motion carried.

- 4. Brenda Shaffer, Pueblo 137-Damage to Mail Box Vogel made a motion to table any action until Council is able to verify whether or not Ms. Shaffer's mailbox is in the Borough right-of-way and to verify with the driver of the plow truck as to whether or not he hit the mailbox with the plow truck. Cornez seconded the motion. 5 ayes and 1 naye. Motion carried.

Dinsmore & Shohl-Extension to the Line of Credit Cornez made a motion to enact the Ordinance for the \$6,500,000 General Obligation Note, Series of 2010 naming the purchaser of that bond as Somerset Trust Company pursuant their proposal dated May 10, 2010. Vogel seconded the motion. 5 ayes and 1 abstention. Motion carried. Stern filed the abstention memorandum with the Borough Secretary.
